THE LEADERSHIP OF THE REGIONAL HOUSE OF
REPRESENTATIVES OF REMBANG REGENCY,

Considering : a. that in order to comply with Article 168 paragraph (1) of the Regulation of the Regional House of Representatives Number 1 of 2024 concerning the Rules of Procedure of the Regional House of Representatives of Rembang Regency, which stipulates that the Standing Committees of the Regional House of Representatives shall submit the results of the implementation of their work plans at a Plenary Session at the end of each year;

b. that for the purpose referred to in letter a, it is necessary to stipulate a Decision of the Regional House of Representatives of Rembang Regency concerning the Approval of the Results of the Implementation of the 2025 Work Plan of the Regional House of Representatives of Rembang Regency;
