REGARDING

APPROVAL OF THE GENERAL BUDGET POLICY (KUA) AND THE PROVISIONAL  
BUDGET CEILING AND PRIORITIES (PPAS) OF THE REGIONAL REVENUE AND  
EXPENDITURE BUDGET OF REMBANG REGENCY FOR FISCAL YEAR 2026

THE LEADERSHIP OF THE REGIONAL HOUSE OF  
REPRESENTATIVES  
OF REMBANG REGENCY ,

- Considering : a. that in order to comply with the mandate of Article 90 paragraph (1) of Government Regulation Number 12 of 2019, it is stipulated that the Regional Head shall submit the Draft General Budget Policy (KUA) and the Draft Provisional Budget Ceiling and Priorities (PPAS), that pursuant to Article 89 paragraph (1) of Government Regulation Number 12 of 2019, the Regional Head shall submit the Draft KUA and Draft PPAS no later than the second week of July to be discussed and jointly agreed upon between the Regional Head and the Regional House of Representatives (DPRD);
- b. that for the purpose referred to in letter a, it is necessary to obtain the approval of the Regional House of Representatives of Rembang Regency by stipulating a Decree of the Regional House of Representatives of Rembang Regency;

- Bearing in mind : 1. Law Number 17 of 2003 concerning State Finance;
2. Law Number 25 of 2004 concerning the National Development Planning System;
3. Law Number 12 of 2011 concerning the Formation of Laws and Regulations, as amended by Law Number 13 of 2022 concerning the Second Amendment to Law Number 12 of 2011 concerning the Formation of Laws and Regulations;
4. Law Number 23 of 2014 concerning Regional Government, as amended several times, most recently by Law Number 6 of 2023 concerning Job Creation;
5. Law Number 1 of 2022 concerning Financial Relations between the Central Government and Regional Governments;

6. Government Regulation Number 12 of 2019 concerning Regional Financial Management;

Taking into consideration : 1. The results of the meeting of the Budget Committee of the Regional House of Representatives of Rembang Regency with the Regional Government Budget Team of Rembang Regency on 10 November 2025;

2. The Plenary Meeting of the Regional House of Representatives of Rembang Regency on 13 November 2025;

HEREBY DECIDES:

To stipulate :  
FIRST : To approve the Draft General Budget Policy (KUA) and the Draft Provisional Budget Ceiling and Priorities (PPAS) of the Regional Revenue and Expenditure Budget of Rembang Regency for Fiscal Year 2026.

SECOND : To submit the subsequent process as referred to in the FIRST dictum of this Decree to the Regent of Rembang.

THIRD : This Decision shall enter into force on the date of its stipulation.
