APPROVAL OF THE ENACTMENT OF THE DRAFT REGULATION OF THE  
REGIONAL HOUSE OF REPRESENTATIVES OF REMBANG REGENCY ON RULES  
OF PROCEDURE

THE REGIONAL HOUSE OF REPRESENTATIVES OF  
REMBANG REGENCY,

- Considering :
- a. that the Special Committee established and determined by Decision of the Regional House of Representatives Number 7 of 2025 concerning the Code of Ethics and Rules of Procedure of the Regional House of Representatives of Rembang Regency has conducted deliberations and in-depth discussions on the Draft Regulation of the Regional House of Representatives concerning Rules of Procedure;
  - b. that the results of the deliberations and in-depth discussions on the Draft Regulation of the Regional House of Representatives as referred to in letter a have obtained approval from the Members in the Plenary Session;
  - c. that for the purposes referred to in letter a and letter b, it is necessary to stipulate a Decision of the Regional House of Representatives concerning the Approval of the Enactment of the Draft Regulation of the Regional House of Representatives of Rembang Regency on Rules of Procedure;
- Bearing in mind :
1. Law Number 13 of 1950 concerning the Establishment of Regions within the Province of Central Java;
  2. Law Number 12 of 2011 concerning the Formation of Laws and Regulations, as amended by Law Number 15 of 2019 concerning Amendments to Law Number 12 of 2011 concerning the Formation of Laws and Regulations;
  3. Law Number 23 of 2014 concerning Regional Government (State Gazette of the Republic of Indonesia of 2014 Number 244, Supplement to the State Gazette of

the Republic of Indonesia Number 5587), as amended several times, most recently by Law Number 6 of 2023 concerning the Stipulation of Government Regulation in Lieu of Law Number 2 of 2022 concerning Job Creation (State Gazette of the Republic of Indonesia of 2023 Number 41, Supplement to the State Gazette of the Republic of Indonesia Number 6856);

4. Law Number 1 of 2022 concerning Financial Relations between the Central Government and Regional Governments;
5. Government Regulation Number 12 of 2018 concerning Guidelines for the Preparation of Rules of Procedure of Regional Houses of Representatives at the Provincial, Regency, and Municipal Levels;
6. Regulation of the Regional House of Representatives of Rembang Regency Number 1 of 2024 concerning the Rules of Procedure of the Regional House of Representatives of Rembang Regency;

Taking into Consideration : The Plenary Session of the Regional House of Representatives held on 23 July 2025.

HEREBY DECIDES:

- To Stipulate :
- FIRST : To approve the enactment of the Draft Regulation of the Regional House of Representatives of Rembang Regency concerning Rules of Procedure.
- SECOND : The Draft Regulation of the Regional House of Representatives as referred to in the FIRST dictum shall be enacted as a Regulation of the Regional House of Representatives after the facilitation results from the Governor of Central Java have been received.
- THIRD : This Decision shall come into force as of the date of its stipulation.
