ACCOUNTABILITY REPORT FOR FISCAL YEAR 2024

THE LEADERSHIP OF THE DPRD OF REMBANG
REGENCY,

- Considering : a. that in accordance with Article 75 paragraph (1) of the Regulation of the Regional House of Representatives Number 1 of 2024 concerning the Rules of Procedure, a Special Committee shall be established in a plenary meeting upon the proposal of DPRD members after obtaining consideration from the House Committee;
- b. that pursuant to Article 76 paragraph (3) of the Regulation of the Regional House of Representatives Number 1 of 2024 concerning the Rules of Procedure, the Chairperson and Vice Chairperson of a Special Committee shall be elected from and by the members of the Special Committee;
- c. that based on the considerations as referred to in letters a and b, it is necessary to stipulate a Decree of the Regional House of Representatives concerning the Establishment of the Members of Special Committees I, II, III, and IV of the Regional House of Representatives of Rembang Regency in discussing the Regent's Government Performance Accountability Report for Fiscal Year 2024;
- Bearing in mind : 1. Law Number 13 of 1950 concerning the Establishment of Regencies within the Province of Central Java;
2. Law Number 33 of 2004 concerning Fiscal Balance between the Central Government and Regional Governments;
3. Law Number 23 of 2014 concerning Regional

Government, as amended several times, most recently by Law Number 11 of 2020 concerning Job Creation;

- 4. Government Regulation Number 18 of 2017 concerning the Financial and Administrative Rights of the Chairpersons and Members of the Regional House of Representatives;
- 5. Government Regulation Number 12 of 2018 concerning Guidelines for the Formulation of the Rules of Procedure of the Regional House of Representatives of Provinces, Regencies, and Cities;
- 6. Government Regulation Number 12 of 2019 concerning Regional Financial Management;
- 7. Regulation of the Regional House of Representatives Number 1 of 2021 concerning Amendments to the Regulation of the Regional House of Representatives Number 1 of 2019 concerning the Rules of Procedure of the Regional House of Representatives of Rembang Regency;

- THIRD : All costs arising from the stipulation of this Decree shall be charged to the Regional Revenue and Expenditure Budget of Rembang Regency.
- FOURTH : This Decree shall come into force on the date of its stipulation.
