THE ESTABLISHMENT OF THE MEMBERSHIP OF THE SPECIAL COMMITTEE
OF THE REGIONAL HOUSE OF REPRESENTATIVES OF REMBANG REGENCY IN
DISCUSSING GOVERNMENT EMPLOYEES WITH WORK AGREEMENTS (PPPK)
OF REMBANG REGENCY FOR THE YEAR 2025

THE LEADERSHIP OF THE REGIONAL HOUSE OF
REPRESENTATIVES,

- Considering :
- a. that pursuant to Article 75 paragraph (1) of the Regulation of the Regional House of Representatives Number 1 of 2024 concerning Rules of Procedure, a Special Committee shall be established in a plenary session upon the proposal of members of the Regional House of Representatives after obtaining consideration from the House Committee;
 - b. that pursuant to Article 76 paragraph (3) of the Regulation of the Regional House of Representatives Number 1 of 2024 concerning Rules of Procedure, the Chairperson and Vice Chairperson of the Special Committee shall be elected from and by the members of the Special Committee;
 - c. that based on the considerations as referred to in letter a and letter b, it is necessary to stipulate a Decision of the Regional House of Representatives concerning the Establishment of the Membership of the Special Committee of the Regional House of Representatives of Rembang Regency in discussing Government Employees with Work Agreements (PPPK) of Rembang Regency for the year 2025;
- Bearing in mind :
1. Law Number 13 of 1950 concerning the Establishment of Regency Regions within the Province of Central Java;
 2. Law Number 33 of 2004 concerning the Fiscal Balance between the Central Government and Regional Governments;
 3. Law Number 23 of 2014 concerning Regional

Government, as amended several times, most recently by Law Number 11 of 2020 concerning Job Creation;

- 4. Government Regulation Number 18 of 2017 concerning Financial and Administrative Rights of the Leadership and Members of the Regional House of Representatives;
- 5. Government Regulation Number 12 of 2019 concerning Guidelines for the Formulation of Rules of Procedure of Provincial, Regency, and Municipal Regional Houses of Representatives;
- 6. Government Regulation Number 12 of 2019 concerning Regional Financial Management;
- 7. Regulation of the Regional House of Representatives of Rembang Regency Number 1 of 2021 concerning Amendment to Regulation of the Regional House of Representatives Number 1 of 2019 concerning the Rules of Procedure of the Regional House of Representatives of Rembang Regency;
