THE APPROVAL FOR THE ENACTMENT OF THE DRAFT REGIONAL  
REGULATION ON THE MEDIUM-TERM REGIONAL DEVELOPMENT PLAN OF  
REMBANG REGENCY FOR THE YEARS 2025–2029

THE LEADERSHIP OF THE REGIONAL HOUSE OF  
REPRESENTATIVES OF REMBANG REGENCY,

- Considering : a. that pursuant to Article 11 paragraph (1) of DPRD Regulation Number 1 of 2024 concerning the Rules of Procedure of the Regional House of Representatives of Rembang Regency, a Draft Regional Regulation originating from the DPRD or the Regent shall be discussed jointly by the DPRD and the Regent in order to obtain joint approval;
- b. that the Draft Regional Regulation concerning the Medium-Term Regional Development Plan (RPJMD) of Rembang Regency for the Years 2025–2029 has been deliberated by the Special Committee and approved in the Plenary Session
- c. that based on the considerations as referred to in letters (a) and (b), it is necessary to stipulate a DPRD Decision concerning the Approval for the Enactment of the Draft Regional Regulation on the Medium-Term Regional Development Plan of Rembang Regency for the Years 2025–2029;
- Bearing in mind : 1. Article 18 paragraph (6) of the Constitution of the Republic of Indonesia of 1945;
2. Law Number 13 of 1950 concerning the Establishment of Regency Regions within the Province of Central Java;
3. Law Number 25 of 2004 concerning the National Development Planning System;
4. Law Number 23 of 2014 concerning Regional Government, as amended several times, most recently by Law Number 6 of 2023 concerning the Stipulation of Government Regulation in Lieu of Law Number 2 of 2022

concerning Job Creation;

- 5. Government Regulation Number 8 of 2008 concerning the Stages, Procedures for the Preparation, Control, and Evaluation of the Implementation of Development Plans;
- 6. Regional Regulation of Rembang Regency Number 2 of 2023 concerning the Spatial Plan of Rembang Regency for the Years 2023–2043;


Having regard : The deliberations conducted during the Plenary Session  
to on Wednesday, 6 August 2025.

HEREBY DECIDES:

- To Stipulate :
- FIRST : To approve the enactment of the Draft Regional Regulation concerning the Medium-Term Regional Development Plan of Rembang Regency for the Years 2025–2029.
- SECOND : The Draft Regional Regulation of Rembang Regency for the Years 2025–2029 as referred to in the FIRST dictum is attached and constitutes an inseparable part of this Decision
- THIRD : To submit the subsequent process as referred to in the FIRST dictum of this Decision to the Regent of Rembang.
- FOURTH : This Decision shall enter into force on the date of its stipulation.
