IN DISCUSSING THE REGIONAL REGULATION ON THE CODE OF ETHICS AND  
THE RULES OF PROCEDURE OF THE DPRD OF REMBANG REGENCY

THE LEADERSHIP OF THE DPRD OF REMBANG  
REGENCY,

- Considering : a. that in accordance with Article 75 paragraph (1) of DPRD Regulation of Rembang Regency Number 1 of 2024 concerning the Rules of Procedure of the Regional House of Representatives, it is stipulated that a Special Committee shall be established in a plenary meeting upon the proposal of DPRD members after obtaining consideration from the House Committee, and Article 75 paragraph (2) stipulates that the establishment of a Special Committee shall be determined by a DPRD Decree;
- b. that based on the consideration as referred to in letter a, it is necessary to stipulate a Decree of the Regional House of Representatives concerning the Establishment of the Chairpersons and Members of Special Committees I and II of the Regional House of Representatives of Rembang Regency in discussing Regional Regulations;
- Bearing in mind : 1. Law Number 12 of 2011 concerning the Formation of Laws and Regulations, as amended several times, most recently by Law Number 13 of 2022 concerning the Second Amendment to Law Number 12 of 2011 concerning the Formation of Laws and Regulations;
2. Law Number 17 of 2014 concerning the People's Consultative Assembly, the House of Representatives, the Regional Representative Council, and the Regional House of Representatives, as amended several times, most recently by Law Number 13 of 2019 concerning the Third Amendment to Law Number 17 of 2014;

3. Law Number 23 of 2014 concerning Regional Government, as amended several times, most recently by Law Number 6 of 2023 concerning the Stipulation of Government Regulation in Lieu of Law Number 2 of 2022 concerning Job Creation;
4. Law Number 11 of 2023 concerning Central Java Province;
5. Government Regulation Number 18 of 2017 concerning the Financial and Administrative Rights of the Chairpersons and Members of the Regional House of Representatives, as amended by Government Regulation Number 1 of 2023;
6. Government Regulation Number 12 of 2018 concerning Guidelines for the Preparation of the Rules of Procedure of the Regional House of Representatives of Provinces, Regencies, and Cities;
7. Regional Regulation of Rembang Regency Number 2 of 2017 concerning the Financial and Administrative Rights of the Chairpersons and Members of the Regional House of Representatives of Rembang Regency;

To establish the Chairpersons and Members of Special Committees I and II of the Regional House of Representatives of Rembang Regency to discuss two (2) Draft Regional Regulations of Rembang Regency to become Regional Regulations of Rembang Regency.
